



SKYRACE REGULATION EXTREME - 27 km



Art.1 Organization

The organizer of the Cima d'Asta S kyrace is the **Ski Team Lagorai Tesino A.S.D.** (Committee Organizer - C.O.) - Via Dante, 10 Castello Tesino (TN), 38053 - C.F. and P.I. 02427270224.

Art. 2 General information

The race will take place on Sunday 21 August 2022 starting at 08:00 from the campsite Val Malene, on a path of about 27 km with an elevation gain of about 2400 meters in positive and equally in the negative.

Art.3 Participation requirements

Participation is allowed to athletes, both male and female, over the age of 18, and in possession of the medical certificate of suitability for competitive-sporting practice issued by a sports medicine center for athletics, skyrunning, skiing cross-country, ski mountaineering and valid on race day.

Art.4 Limit of participants

A limit is placed on the number of registrations set at 250. Over this limit, registrations will only be accepted as reservations.

Art. 5 Withdrawal of bibs and race pack

Each competitor will receive, at the race office, a bib upon presentation of a valid identification document.

Bib collection is fixed from 1.30 pm to 5.30 pm on Saturday 20 August and from 5.30 am to 7:30 am on Sunday 21 August at the Camping Val Malene.

In case of no show at the bib and race pack collection, the latter will not come stored and shipped.

Art. 6 Registration

Registrations will be considered valid only upon payment of the fee of registration through the established methods. If the registration limit is reached, the organization considers itself free to accept new registrations to take over for those who do not had still made the payment by August 15th.

Registrations are managed by the Wedosport portal.

The participation fee is variable and amounts to:

- € 30 for the first 50 competitors;
- € 35 over 50 competitors and up to 30/06/2022;
- € 45 from 01/07/2022 to 07/08/2022;
- € 50 from 09/08/2022 to 20/08/2022.

Participation in the competition is bound by the membership of FISky.

For those who do not have an annual membership card with FISky, it is possible to request one card valid only for the day of the competition at a cost of € 5.00 (price established by the Federation), additional to the cost of the competition. This request comes collected directly at the time of registration on the specific portal.

In case of cancellation of the registration by 30/06/2022, the entire fee will be refunded registration, except for secretarial costs (€ 2.00). After that date, the Committee Organizer reserves the right to reimburse 50% of the cost. After 08/18/2022 not Registration fees will be refunded, except if the race is cancelled by the organizing committee.

Registration is nominative. The exchange or transfer of the registration is not allowed nor the passage from one race to another. Any changes must be requested to the Organization and have a cost of € 5.00.

Art. 7 Difficulty of the race

The race will take place along mountain trails with a challenging course of climbs and descents on trails classified "EE" which include some exposed and aided passages. Good physical preparation and habituation to routes on high-altitude mountain trails are therefore required.

Art. 8 Checkpoint and refreshment points

An intermediate check and control point will be set up on the summit of Cima d'Asta (2847 m).

The participant is obliged to have been duly registered.

Failure to detect the passage to a control point will result in disqualification.

The organization reserves the right to carry out the checks in non-points declared.

Along the way there will be n. 2 complete refreshment points with food and water and 3 sources of water.

At the refreshment points there are special containers for the delivery of waste such as glasses, packaging etc. Anyone caught littering outside of such spaces will be disqualified from the competition.

Art.9 Maximum time and time delays

For the safety of the athletes, there are two gates to check the maximum time allowed, the first at Forcella Magna (3:00 hours from departure) and the second at the crossroads before the entrance to the Canalone Bassanesi (4:30 from the start).

Competitors who do not pass the gates within the established deadline are obliged to stop.

From this moment on, the athlete who does not pass the time gate becomes a normal hiker.

The maximum time to finish the race is set at 9 hours.

Assistance will no longer be guaranteed when the finish line closes (maximum time) along the way.

Art.10 Timekeeping

The timing service with electronic chip is provided by Wedosport.

Art. 11 Withdrawals

The competitor who will abandon the race must obligatorily communicate it to any control point showing the assigned bib number at the same time. In the if the withdrawal does not require medical intervention, the athlete will have to return independently to the nearest exit point, pre-established by the Organization and promptly indicated, informing the staff in charge who will be on site. From this moment on, the athlete becomes a normal hiker.

Art. 12 Disqualifications

On the course there will be staff members authorized to verify compliance with the regulation by the participants.

The competition judges have the right to sanction the immediate disqualification and communicate to the race jury the infringements found.

The C.O. will apply the disqualification following one of the following infractions:

- Absence of mandatory material as indicated in the list in art. 14 "Material";
- Refusal to submit to the control;
- Abandonment of the marked race course;

- Abandonment of waste by the runner or his companions;
- Failure to aid another runner in difficulty;
- Refusal to comply with an order from the race director, a race judge, a doctor or rescue;
- Departure from a checkpoint after the cut-off time;
- Failure to pass through a control point;
- Use of a means of transport;
- Incorrect behavior towards members of the organization;
- Bib sharing and / or exchange;
- Support of a guide along the route;
- Assistance outside the permitted points;
- Any infringement of the competition rules.

The disqualification is immediate, and the runner must stop the race.

The irregularities ascertained by means of video images received by the organization also after the match, they may cause disqualification

Art. 13 Course changes - cancellation of the race

In case of bad weather, the competition can be carried out on an alternative route; the organization will be able to decide, in the event of particularly weather conditions difficult, to suspend the race during its development: in this case the ranking will be drawn up based on the steps taken at the last check. In the event of this decision the prize money will be halved.

The organization reserves the right to temporarily suspend, or interrupt, definitively the race for all or part of the competitors if there are situations that can seriously compromise the safety of athletes or people present along the route (e.g. helicopter rescue operations, falling stones / boulders, weather conditions prohibitive etc ..).

The organization reserves the right to change the route or location at any time of the rescue and refreshment points and the time gates, without notice.

In case of need, the organization reserves the right to modify or eliminate some features of route.

Art. 14 Material

Each competitor must present himself at the start MANDATORY equipped with:

- Personal windproof / rainproof jacket;
- Tank top or T-shirt (it is forbidden to compete bareback);
- Bib provided by the organization;
- Skyrunning shoes;
- Thermal blanket;
- Whistle;
- Glass / bottle / camel bag;
- Mobile phone;
- Respiratory protection device (surgical masks, FFP2 or higher, community masks), if required by current regulations.

If during the course or upon arrival an athlete is found without such the penalties foreseen by the FISKY and ISF regulations will be applied.

The recommended material includes:

- Hat / bandana / buff;
- Sun protection glasses;
- Backpack or pouch;
- Spare clothing;
- Front lamp;

Art. 15 Use of rackets / sticks

The use of snowshoes / poles is normally allowed along the entire route, except for areas where they are expressly forbidden by a specific poster designer and / or by staff present on the course.

In the presence of ropes and / or aided sections it is recommended to store the poles / rackets in the backpack or shoulder strap, in order to increase the safety of progression along these stretches technicians.

The organization does not provide poles transport service.

Art. 16 Complaints

Any complaints after the race must reach the jury within 30 minutes from the display of the order of arrival, accompanied by € 50.00 returnable if the complaint was accepted.

Art. 17 Assistance of the staff of the O.C.

Along the way there will be some staff members to ensure the correct conduct of the competition, it will be present on all intersections and in more challenging and dangerous sections.

The organization will offer tender assistance also with the support of the National Alpine Rescue Organization and Alpine Rescue of "Guardia di Finanza", in the most challenging sections of the route.

Said staff will also possibly be in charge the management of emergencies or injuries along the way.

For anything not specified in this regulation, please refer to the rules of the regulation FISKY-ISF 2022.

The Organizing Committee declines all responsibility for any accidents caused by the conduct of third parties who are on the race course for any reason or for anyone who runs out of competition, companions or spectators.
